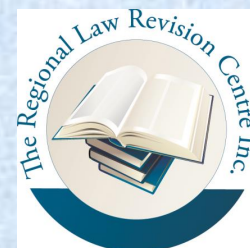
About us

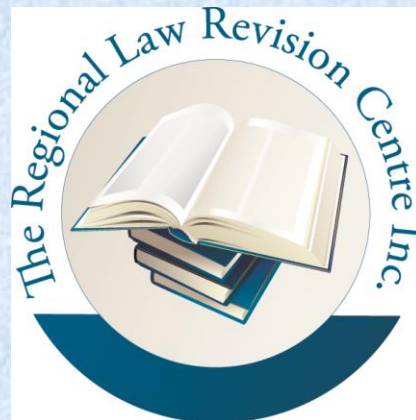

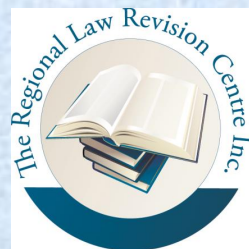
Recent Development

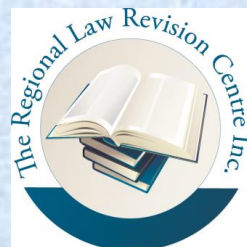
This MOU provides for the provision of experts and services by the Centre.

Data Capture

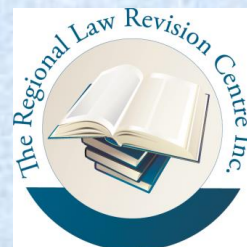
Data capture is an integral process for the consolidation and revision of Laws.

- Presentation of the Laws in published volumes and format compatible with CD-ROMs, Ipad, Kindle and data-enabled cell phones.

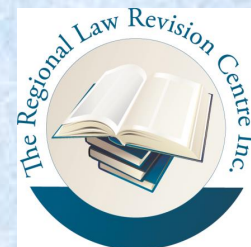

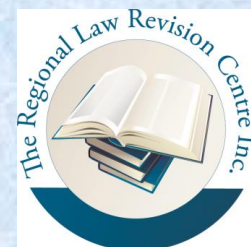

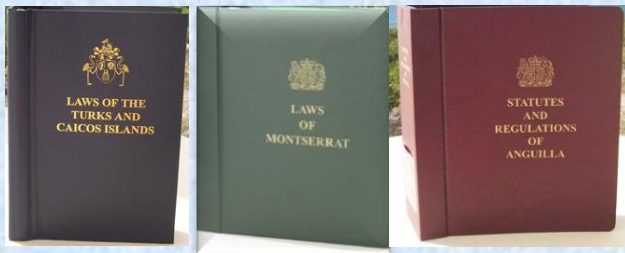

Printing Service

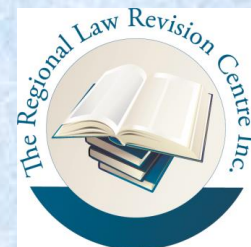
We are equipped with the latest digital printers and we provide on-demand printing for our customers. We print only what is initially required and additional print orders are produced as requested.

We also ensure that all legislation is packaged and appropriately labelled before shipment.

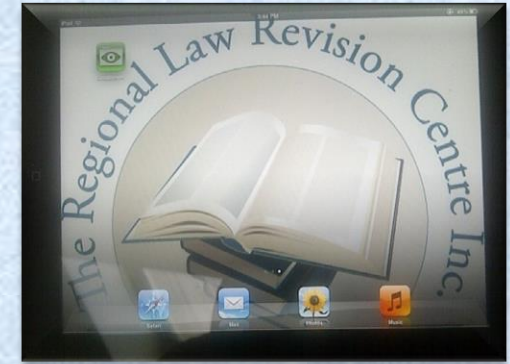

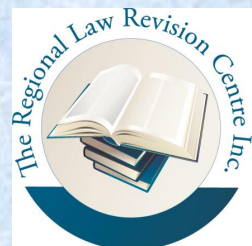
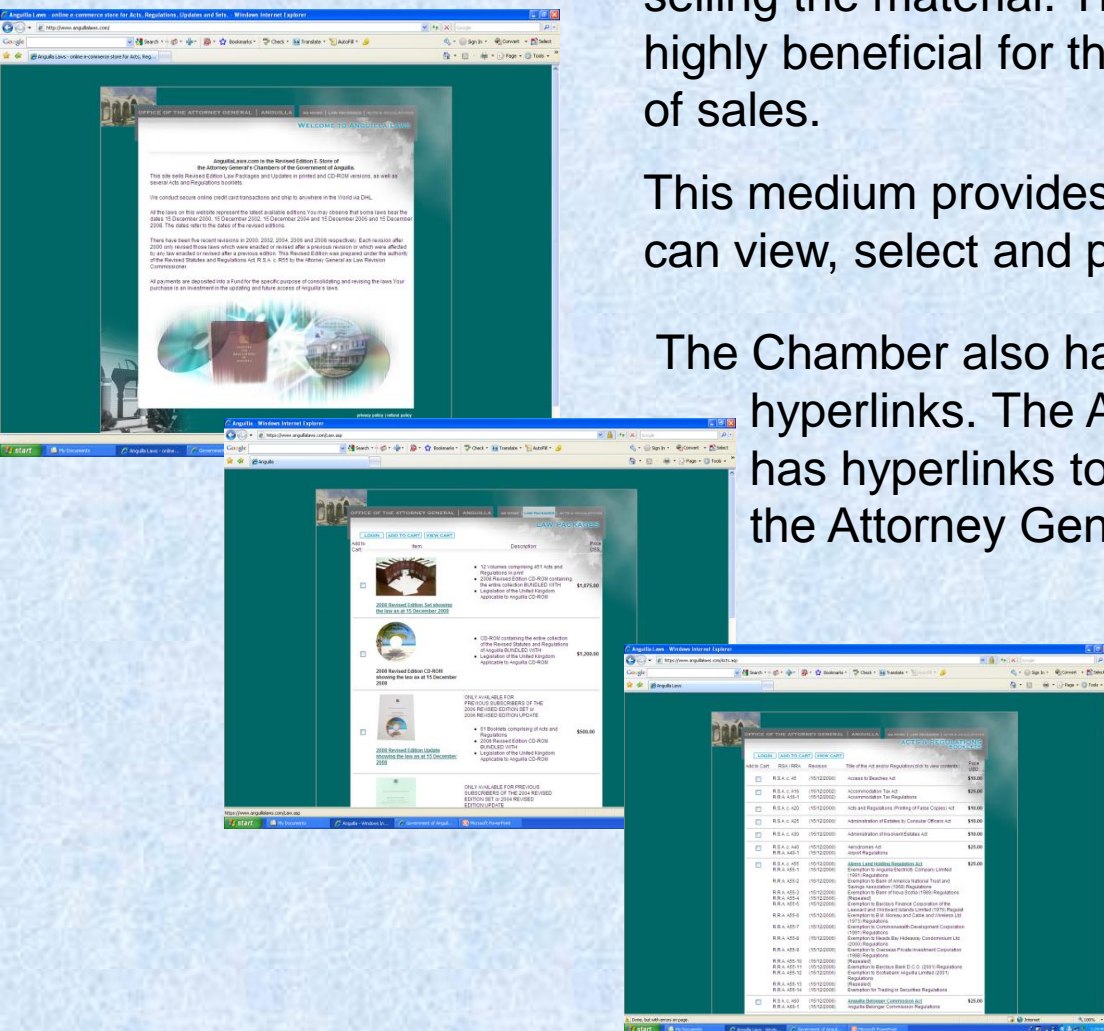
E-Commerce Website

The Regional Law Revision Centre Inc. provides a comprehensive training course on the Consolidation of Laws.

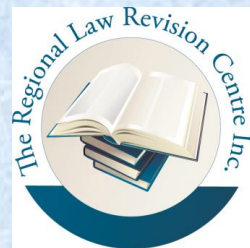
The objective of conducting this training is to empower Chambers' staff on the consolidation process with detailed focus on the following areas.

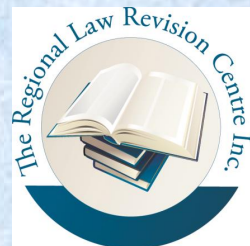

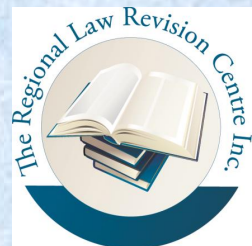

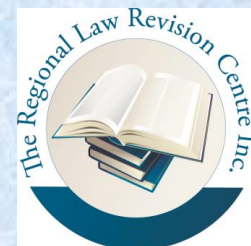
